

Indigo Expat UK - Premiums

Individual policies for the United Kingdom

How should you use Indigo Expat UK premiums to calculate your annual budget?

Step 1: first select your **currency** between GBP and EURO (premiums / limits are expressed automatically in the same currency) and consider the corresponding pages

Step 2: do you opt for a **first euro plan** (i.e. 100% with a private Insurer) or on **Top-Up** to CFE (French)?

Step 3: which plan best fits to your needs between **Indigo Expat UK 70 or 100**?

Step 4: in the table, please select premiums according to the age of each member at the effective date of the contract

Step 5: if you want to opt for the option « **evacuation & repatriation** », please add the corresponding premium multiplied by the number of members

You calculated **your annual budget**.

Important notes:

- Our premiums are expressed in whole numbers (i.e. without any cents or pence etc.), so please note that payment frequency surcharge percentages may be slightly higher or lower than those stated.
- Payment charges are subject to the following administration surcharges: 0% for annual payment, 3% for half yearly payments, 4% for quarterly payments and 5% for monthly payments.
- If Insurance Premium Tax and other government levies apply, these will be stated on your invoice/payment details letter.
